ORDINANCE NO. 2023-____

AN ORDINANCE TO AMEND THE PRAIRIE GROVE MUNICIPAL

CODE REGARDING LETTERS OF CREDIT FOR IMPROVEMENTS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PRAIRIE

GROVE, ARKANSAS, THAT:

Section One: Title. This Ordinance shall be known as the 2023 Subdivision

Improvements Amendment.

Section Two: Section 15.16.03 Amended. Section 15.16.03 of the Prairie Grove

Municipal Code shall be amended to read as follows:

15.16.03 Guarantees in lieu of installed improvements.

The planning commission may approve the final plat of a subdivision prior to the installation of all the required improvements if the subdivider:

- A. *Deposits cash or a surety bond*. Such deposits of cash or a surety bond with the city shall be in an amount equal to the estimated cost of the improvements as determined by the city engineer and city council for the entire subdivision or portion thereof. Upon satisfactory completion of the improvements, the subdivider may withdraw any deposit made; or
- B. Provide an irrevocable letter of credit. Such letter of credit must be provided by a bank listed pursuant to A.C.A. §19-8-105. The amount of such letter of credit shall be equal to the estimated cost of the improvements as determined by the city engineer and city council for the entire subdivision or portion thereof. The term for such letter of credit shall be 36 months and shall not be renewable. If all improvements are not completed within 35 months of the date of issuance of the letter of credit, the subdivider shall be in default and the city will make claim on the letter of credit in an amount estimated to provide completion of all unbuilt improvements. Such letter of credit shall be in substantially the same form as Attachment 1 hereto.

<u>Section Three:</u> <u>Effective Date.</u> This Ordinance shall become effective 60

days following its posting unless an Emergency Clause is affixed.

Section Four: Change in Security. Persons who currently have a cash or surety

bond on file with the City may replace such with an irrevocable letter of credit.

The expiration of any such letter of credit shall be 36 months from the date they

posted their cash or surety bond and default shall occur 35 months from such date.

<u>Section Five: Repealing Clause.</u> Ordinances or parts thereof in force at the time that this ordinance shall take effect that are in conflict herewith, are hereby repealed.

<u>Section Six:</u> <u>Saving Clause.</u> Nothing herein shall be deemed to affect any rights or obligations existing at the time of the passage of this ordinance.

<u>Section Seven:</u> <u>Severability Clause.</u> In the event any portion of this ordinance is declared inoperative or invalid as a result of a statute or judicial decision, then only that portion expressly so declared to be inoperative or invalid shall be affected thereby and all other provisions hereof shall remain in full force and effect.
