WHEREAS, Arkansas Code Annotated § 14-58-202 requires the council to adopt a budget on or before February 1st of each year; and



WHEREAS, the best and lowest, responsible bid was submitted by Crossland Heavy Contractors, Inc. for the following price:


\$1,235,200.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF PRAIRIE GROVE, ARKANSAS THAT:


