CITY OF PRAIRIE GROVE, ARKANSAS:**



WHEREAS, the City of Prairie Grove is a member of the Benton/Washington Regional Public Water Authority; and


WHEREAS, the City is entitled to a representative and an alternate representative on the Authority's board of directors.
