

RESOLUTION NO. 2020-3

A RESOLUTION BY THE CITY TO AUTHORIZE A CONTRACT WITH PREFERRED OFFICE TECHNOLOGIES TO PROVIDE IT SERVICES TO THE CITY.

WHEREAS, the District Court has need for IT services for its computer and storage systems; and

WHEREAS, the City desires to use the services of Preferred Office Technologies to provide such IT services to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PRAIRIE GROVE, ARKANSAS:

That the City Council hereby authorizes the Mayor and Clerk:

1. To enter into a contract with Preferred Office Technologies to provide IT services to the City (except for the District Court) for a fee of \$1,185.00 per month and a one-time charge of \$7800.00 to provide a new server.
2. To take such steps as are necessary and incident to its implementation.

RESOLUTION NO. 2020-4

A RESOLUTION BY THE CITY TO OPEN A NEW BANK ACCOUNT AND TO TRANSFER TWO ACCOUNTS TO THE BANK OF FAYETTEVILLE

WHEREAS, the City recently passed an Ordinance to collect a jail fee; and

WHEREAS, the City needs to open a separate bank account with Arvest Bank to be called the Jail Fee Fund account; and

WHEREAS, Mayor Sonny Hudson, Larry Oelrich and Christine Kelly should be listed as signatories on such account and all activity should require at least two of their signatures; and

WHEREAS, the Street Department Equipment Reserve Fund account and Sanitation Equipment Reserve Fund account, currently at Arvest Bank should be closed and new accounts opened at the Bank of Fayetteville; with Mayor Sonny Hudson, Larry Oelrich and Christine Kelly listed as signatories on each account and all activity should require at least two of their signatures.



RESOLUTION NO. 2020-5

A RESOLUTION BY THE CITY TO SUPPORT THE PASSAGE OF A WASHINGTON COUNTY ¼-CENT SALES AND USE TAX TO BE USED TO FUND THE IMPLEMENTATION OF A NEW EMERGENCY SERVICES RADIO NETWORK.

WHEREAS, there is a special election to be held March 3, 2020, to enact a county-wide 0.25% sales and use tax to be used to fund a new county-wide emergency services radio network; and

WHEREAS, without adoption of this sales and use tax the county and cities within the county will be unable to fund a much needed improvement to the emergency services radio network used in the county; and

WHEREAS, the one-quarter percent sales and use tax will only be in effect for twelve (12) months; and


WHEREAS, it is beneficial for all municipalities to support the proposal as a necessary funding mechanism for our emergency services communication infrastructure.

That the City Council hereby supports the passage of the one-quarter percent (0.25%) county sales and use tax for twelve (12) months at the March 3, 2020 special election.



WHEREAS, the Police Chief has revised the Missing Persons/Amber Alert Plan Policy (2018-01) to comply with recent changes to state law; and


WHEREAS, it is the responsibility of the City Council to be the body to approve all policy decisions on the behalf of the City.
