**A RESOLUTION BY THE CITY TO AUTHORIZE THE PURCHASE OF A NEW

WHEREAS, the City Council must approve any expenditure over \$20,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF PRAIRIE


GROVE THAT:

RESOLUTION NO. 2016-04

A RESOLUTION BY THE CITY TO DECLARE EQUIPMENT AS SURPLUS AND AUTHORIZING THE MAYOR TO SELL OR OTHERWISE DISPOSE OF THEM

WHEREAS, the City of Prairie Grove owns equipment used for city purposes; and

WHEREAS, such equipment has a limited useful life; and

WHEREAS, the City currently owns the equipment on the attached list that has reached the end of its useful life with the City; and



WHEREAS, the City owns real property formerly used as a recycling facility but no longer needed for municipal purposes; and


WHEREAS, it would be in the best interests of the City to sell such real property; and
