**A RESOLUTION BY THE CITY TO ACCEPT A BID FROM CROSSLAND HEAVY CONTRACTORS FOR THE CONSTRUCTION OF THE NEW BRIDGE ON PARKS STREET**

**WHEREAS**, the City needs to replace the Parks Street Bridge; and

**WHEREAS**, the City has advertised for bids from qualified bidders for the construction of the bridge; and

**WHEREAS**, Crossland Heavy Contractors of Rogers, Arkansas has submitted the low bid of \$579,953.05; and


**WHEREAS**, the City has determined that Crossland Heavy Contractors is qualified and capable of constructing the bridge in accordance with bid specifications.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PRAIRIE GROVE, ARKANSAS:**

That the City Council hereby authorizes the Mayor and City Clerk to enter into a contract with Crossland Heavy Contractors for the construction of the Parks Street Bridge for a bid price of \$579,953.05 (based on estimated quantities in the bid documents). The Mayor is further authorized to take any ministerial actions required in implementing this contract.

RESOLUTION 2015-25

**A RESOLUTION BY THE CITY TO APPROVE THE 2015 PROPERTY TAX LEVY  
AND AUTHORIZE SUBMISSION TO THE COUNTY QUORUM COURT**

**WHEREAS**, the City of Prairie Grove must determine the extent of the property tax levy for delivery to the Washington County Quorum Court; and

**WHEREAS**, the property tax is an important, fair and reasonable source of general revenue for the ongoing operation of the municipal government; and

**WHEREAS**, it is in the best interest of the people of the City of Prairie Grove that the levy be extended;

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE  
CITY OF PRAIRIE GROVE, ARKANSAS THAT:**

Section 1. The property tax levy for the calendar year 2015 shall be and is recommended to the Quorum Court at:

General Fund: Five mills (5).


Police Department: (voluntary) One mill (1).

Fire Department: (voluntary) One-half mill (0.5).

Section 2. Notwithstanding the language set forth in Section One, nothing contained therein shall preclude Washington County taxing and assessing administrators to bring the City's levy in compliance with any constitutional or statutory requirement.


