**A RESOLUTION BY THE CITY TO AUTHORIZE THE ACCEPTANCE OF

WHEREAS, the City Council finds that the City should accept payments for goods and services via credit and debit cards.


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF

2. Authorizes the City to incur the fees associated with the acceptance of such payments; except for District Court fees and City Utility payments, which shall continue to bear surcharges or convenience fees for acceptance of such payments.

A RESOLUTION BY THE CITY TO AUTHORIZE THE PURCHASE OF A NEW VEHICLE

WHEREAS, the City is in need of new police vehicles; and

WHEREAS, the cost of two such vehicles, equipped as needed, is \$39,738.00 as purchased from Landers Chevrolet under the state purchasing contract, No. 4600030973/SP-14-0001; and

WHEREAS, the City has budgeted for the cost of the vehicles; and

WHEREAS, the Drug Task Force Vehicle Fund will provide \$12,738.00 towards the cost of such vehicles; and

WHEREAS, the City Council must approve any expenditure over \$20,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF PRAIRIE


GROVE THAT:

**A RESOLUTION BY THE CITY TO AUTHORIZE A JOINT USE AGREEMENT WITH
THE PRAIRIE GROVE SCHOOL DISTRICT**

WHEREAS, the Prairie Grove School District owns lands used to provide a location for the operation of a youth soccer program; and

WHEREAS, the Prairie Grove School District and the City of Prairie Grove have agreed to cooperate to install a water hydrant connection and to purchase grass seed to maintain and provide additional area for the soccer program; and

WHEREAS, the Prairie Grove School District and the City of Prairie Grove wish to enter into the attached Joint Use Agreement; and

WHEREAS, the Joint Use Agreement would provide for the City to assist with cost of purchasing grass seed for this youth program and installing a water hydrant connection; and


WHEREAS, the Joint Use Agreement would provide for the District to provide additional funding for the purchase of grass seed and to allow the use of District property for the youth soccer program.

CITY OF PRAIRIE GROVE, ARKANSAS:**



WHEREAS, the Police Chief has: adopted a new policy concerning storage of police department firearms; and


WHEREAS, it is the responsibility of the City Council to be the body to approve all policy decisions on the behalf of the City.
